Exhibitor Registration and Set-up Monday, May 11, 2009 at 4 p.m.

The conference provides an opportunity for government agency representatives, food and drug safety organization representatives, public health educators, industry representatives responsible for product safety and quality assurance, and individuals with food and drug safety interest to interact and obtain timely information and knowledge updates. Conference topics will include: current drug and food safety issues; new safety initiatives; applied safety practices; practical and innovative products and services that foster drug and food safety in the manufacturing and retail environment; current education and training initiatives; and changes in regulatory requirements. Conference daily attendance expected to be 150 daily with a 300 maximum.

Your organization is invited to attend and display products or services that showcase your role in the promotion of drug and food safety. Your participation as an exhibitor will be an integral part of the conference sessions designed for attendee interaction with all presenters. While some participants will provide their own displays units and equipment, we can provide tables for your display purposes. We may also have limited opportunity to have display participants provide short overviews of their respective roles in the promotion of food safety.

Exhibitor registration fee may be waived for government agencies or other non-profit agencies. Individual conference attendee registration would still be required. The registration fee entitles one individual to full conference and activity participation. Additional exhibitor/conference participants will be registered at a reduced conference rate of \$200.00 for each additional person. Hotel room rates are offered at the conference rate of \$155.00 per night and are being extended for pre- and post-conference stays. Exhibitors arriving Monday May 11, 2009 are requested to set up Monday between 4:00pm to 7:00pm to participate in the welcome reception that begins Monday evening prior to the food safety conference start on Tuesday.
