DIRECTIONS:

From Pittsburgh and North, follow signs to the airport, I-279-South. Go through the Ft. Pitt Tunnel. Take Exit 4B (2nd exit when leaving the tunnel) to Parkway Center Dr. Building 7 will be towards the end of the road, on the right, next to the Best Western Hotel.

From the South Hills: Take Rt 51 (Sawmill Run Blvd) North to I-279-South. Follow signs to the airport. Take the next exit, 4B Parkway Center Dr. and follow the road almost to the end. Building 7 will be on the right next to the hotel.

From the Airport: Take Rt 60 towards Pittsburgh, and then I-270-North. Get off at Exit 4A, the Greentree exit. Turn left onto Greentree Rd.
