Driving Directions:

From Lancaster: Take Route 30 West to North George Street. Turn left onto North George Street. Follow that straight for 4 lights, Sovereign Bank Stadium on left.

From Harrisburg and all points North: Take I-83 South to Route 30 West, Exit 22 (N. George St.) Stay in the middle lane and turn right at the light on to North George Street. Follow that straight through 4 lights, Sovereign Bank Stadium on left.

From Gettysburg: Take Route 30 East to North George Street. Turn right onto North George Street. Follow that straight for 4 lights, Sovereign Bank Stadium on left.

From South/ Baltimore: Take I-83 North to South George Street Exit. Follow Business I-83/South George Street to Sovereign Bank Stadium, which will be on your right.
